WHEREAS, the Village Council finds that the foregoing fine schedule would promote the good government of the Village, and that the fines set forth therein are reasonable; and


WHEREAS, this Resolution was considered in open session on the 19<sup>th</sup> day of January, 2021.

RESOLVED that the Fine Schedule attached hereto be and is hereby adopted; and


RESOLVED, that this Resolution shall be effective immediately upon adoption and shall be filed by the Village Manager and kept available for public inspection.
