

Services

Waste Removal in the Village is provided by a contractor; as a result, we receive services in greater frequency than most areas of Montgomery County.

Trash Collection - Trash is collected every **Tuesday and Friday** morning.

Recyclables - Place in the appropriate recyclable bins at curbside on **Wednesday** morning prior to 7 am. The Village participates in a dual stream recycling program. Glass/plastic/aluminum go in one recycling container. Mixed paper should be placed in a separate container. No plastic bags of any type in the recycling bins – take them to the grocery store. Additional excluded items are hazardous/toxic product containers, electronics, plastic wrap, Styrofoam, and needles/syringes/health care supplies.

Yard Waste - Collected in paper bags or yard waste labeled trash cans and placed curbside by 7 am on **Monday** mornings. Runs year round and includes pickup of discarded Christmas trees. Branches can be bundled with twine in 4 ft. lengths and 4 in. diameter. Yard trim in plastic bags will not be collected.

Leaf Collection - Generally from the beginning of October through the end of December. Leaves are left in piles curbside, in front of your property.

Bulk Trash Pick Up - Occurs quarterly in March, June, September and December. Please check the website and monthly newsletter for specific dates.

Sidewalk Maintenance - The Village maintains its own streets and sidewalks. If you have questions regarding any street or sidewalk, please contact the Village Manager. While the Village manages snow removal on its streets, residents are responsible for removing snow and debris off the sidewalks surrounding their property.

Tree Maintenance: Village trees are primarily located within 25 feet from center of street (right-of-way) and are assessed and treated by a certified arborist throughout the year. A spreadsheet of Village trees is posted/updated on the Village website.

Community Engagement

North Chevy Chase CONNECTIONS: A local, all-volunteer nonprofit building a multi-generational community where neighbors get to know and help each other. It offers free opportunities for neighbors to get together including through its Walking Group, Lunch Bunch, Men’s Group, monthly meetings including a Distinguished Neighbor Speakers series, and events for Gardeners and Kids and Families plus a private listserv for information sharing. Those paying annual dues of \$50 per household qualify for volunteer-provided rides and other needed services. North Chevy Chase Swimming Pool: Residents are eligible for membership at the pool at 8817 Brierly Rd. Additional information on membership applications can be found at nccspa.com. Please note there is often a wait list so new residents interested in membership are encouraged to submit applications as soon as possible.

Schools: The Village is zoned for the following public schools: Rosemary Hills (K-2); North Chevy Chase Elementary (3-5); Silver Creek Middle School (6-8); Bethesda-Chevy Chase High School (9-12). July 4 Block Party: The Village hosts an annual block party on the 4th of July and is looking at additional opportunities to bring residents together.

Village Government

Village Council: An elected five-member Council governs the Village of North Chevy Chase. It operates under a charter and regulations approved by the State legislature and County council, respectively. The members of the Council, all of whom are unpaid for their service, are elected at the annual Village meeting in May for two-year terms that begin June 1. To maintain continuity, two members are elected in odd-numbered years and three are elected in even-numbered years. The position that each Council member holds is decided among Council members.

Village Manager: Day-to-day operations of the Village are the responsibility of the Village Manager. The Manager, Susan Theis, is the primary point of

contact for persons seeking information about Village operations, including building permit applications.

Village Meetings: The Council meets on the third Tuesday of the month. Currently, Council meetings are being held virtually, starting at 7:30 p.m. Notification of the meetings goes out on the email distribution list. Please note that the May meeting occurs on the 1st Tuesday of the month, immediately prior to the Annual Village Meeting and the Council does not meet during the month of August. The agenda, including applications for building permits, can be found on the Village website and is sent to residents via email. The meetings are open to the public and residents are encouraged to attend. At the Annual Village meeting, Council members are elected and the Village tax assessment rates voted upon. All residents of the Village who are registered to vote in Montgomery County may be candidates for the Council and may vote at that meeting.

Permits: Please note that the Village of North Chevy Chase has its own permit requirements, beyond County requirements, for demolition/new home construction, exterior additions/modifications, dumpsters, and various other activities. The Village is governed by an elected Council of 5 members and has a part-time Village Manager.
